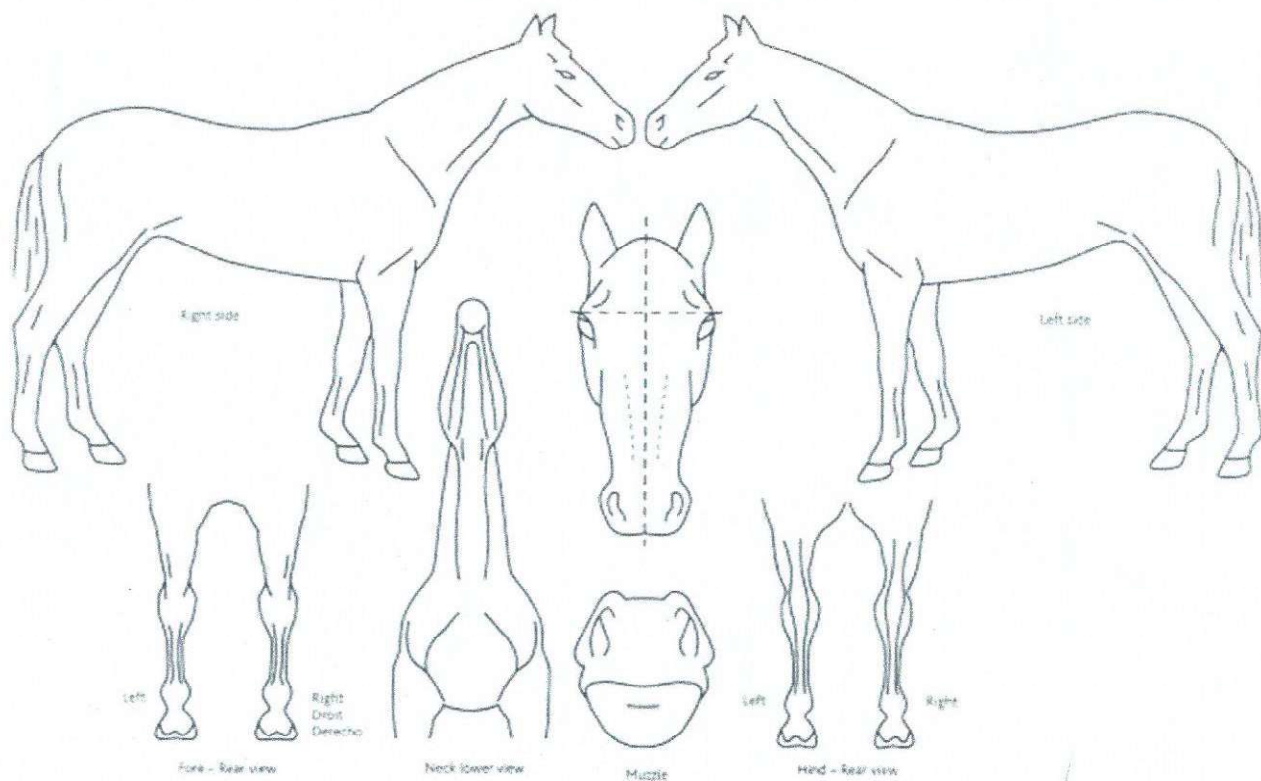

3. Liability shall be limited at all times to that amount covered by the veterinary surgeon's professional indemnity insurance applicable at the time of the examination. Details of the coverage in the form of policy documents for this insurance may be inspected at the veterinary practise premises, and copies of these may be obtained at first request from the veterinary practise at no charge.
4. If the client upon whose instructions the examination was performed is not the owner of the horse, the client is fully responsible for having obtained the owner's consent to all procedures performed during the examination, and the client shall fully indemnify the veterinary surgeon in respect of any claim by the owner arising from an allegation that such consent was not given.
5. In the event the client and/or third parties are the opinion that the health of the horse at the time of the present examination does not correspond to that which is stated in the examination report, these parties must report this to the other party without delay and in writing under penalty of the lapsing of every right of action against the examining veterinarian and/or the veterinary practice, and to hold this party liable for compensation, which also simultaneously providing a copy of this report to the examination veterinarian.
