

The assessment of the radiographs of the naviculars, the proximal sesamoid bones, the fetlock joint, the hock joint and the stifle joint takes place according to the "official assessment schedule". The parts are classified in different grades. Grade 1 and 2 (respectively good and acceptable) are considered **ACCEPTABLE**. Grade 3 for one or more components implies that the components in question entail an **INCREASED RISK** based on the X-ray assessment. Class 4 is definitely **NOT ACCEPTABLE**.

- 1. The examining veterinary surgeon and/or veterinary practice shall not be held liable for loss or damage caused as a result of the performance of the examination or as a result of inaccuracies or shortcomings in their preparation of this report, unless it has been established that this loss or damage is due to malice or negligence on the part of the examining veterinary surgeon.
- 2. The client shall have the sole right to invoke any action due to liability on the part of the examining veterinary surgeon and/or veterinary practice as described under 1 above. - 6. The laws of the Netherlands shall apply exclusively to any disputes arising from the performance of the examination and/or the completion of the examination report, and the Court of the Netherlands shall retain sole juriosdiction to hear these disputes.
